22 **BROADCOM NET SETTLEMENT**

1 **WHEREAS:**

2 A. As of April 30, 2010, Lead Plaintiff and Class Representative, New
3 Mexico State Investment Council (“Lead Plaintiff” or “Class Representative”),
4 acting on behalf of itself and the Settlement Class, entered into a Stipulation and
5 Agreement of Settlement With Broadcom Defendants (the “Stipulation”) with the
6 Settling Defendants in this consolidated action (the “Litigation”).

7 B. By Judgment entered August 12, 2010, the Court approved the
8 Settlement in the amount of \$160,500,000 in cash and approved the proposed Plan
9 of Allocation for the net settlement proceeds (“Net Settlement Fund”).

10 C. By order filed March 10, 2011 (ECF. No. 375), the Court approved
11 the distribution of the Net Settlement Fund to Authorized Claimants and further
12 ordered that any distribution to certain claims-in-process and disputed claims, to
13 the extent they were determined to be eligible to participate in the Settlement,
14 await a supplemental distribution.

15 D. The Court has duly considered the Class Representative’s motion, the
16 declarations with annexed exhibits, the memorandum of law submitted in support
17 thereof, and all of the submissions and arguments presented.

18 NOW, THEREFORE, after due deliberation, IT IS ORDERED,
19 ADJUDGED AND DECREED that:

20 1. This Order incorporates by reference the definitions in the Stipulation,
21 and the Declaration of Ellen Riley in Support of Class Representative’s Motion for
22 Approval of Reserve and Residual Distribution of the Broadcom Net Settlement
23 Fund (“Riley Supplemental Declaration”) and all capitalized terms used herein
24 shall have the same meanings as set forth in those documents.

25 2. The administrative recommendations of The Garden City Group, Inc.
26 (“GCG”), the Court-appointed Claims Administrator, to accept 15 Claims-in-
27 Process, as set forth in Exhibit A-1 to the Riley Supplemental Declaration, are
28 hereby APPROVED.

1 3. Wholly rejected or otherwise ineligible Claims-in-Process, as set forth
2 in Exhibit A-2 to the Riley Supplemental Declaration, are hereby REJECTED.

3 4. The administrative recommendations of GCG to accept 58 late but
4 otherwise eligible Proofs of Claim (the Late-Submitted Claims), as set forth in
5 Exhibit B-1 to the Riley Supplemental Declaration, are hereby APPROVED.

6 5. Wholly rejected or otherwise ineligible Late-Submitted Claims, as set
7 forth in Exhibit B-2 to the Riley Supplemental Declaration, are hereby
8 REJECTED.

9 6. The administrative recommendations of GCG to accept eight claims
10 that have been revised since the Distribution, as set forth in Exhibit C to the Riley
11 Supplemental Declaration, are hereby APPROVED.

12 7. Based on the Court's review and the recommendation of the Claims
13 Administrator, and the Special Master, the 17 Disputed Claims, as set forth in the
14 Claims Administrator Declaration Concerning Disputed Claims and Payments are
15 hereby REJECTED.

16 8. The supplemental distribution plan proposed by GCG in the Riley
17 Supplemental Declaration is APPROVED.

18 9. A payment in the amount of \$206,522.29 from the Settlement Fund
19 for the outstanding fees and expenses of the Claims Administrator, The Garden
20 City Group, Inc., in payment for the balance of its fees and expenses in connection
21 with the administration of the Settlement and its fees and expenses to be incurred
22 in connection with the supplemental distribution of the Net Settlement Fund is
23 hereby APPROVED.

2 concerning the administration of the Settlement, and such other and further relief
3 as this Court deems appropriate.
